To figure out if you qualify for food stamps, Washington needs to know your:

Household size: How many people you live and buy/make food with.; Income: How much money your household makes.

This includes both earned income (the money you make from jobs) and unearned income (cash assistance, Social Security, unemployment insurance, and child support, etc.).
