### Jim Crow Laws And African

Jim Crow laws were state and local laws that enforced racial segregation in the Southern United States. These laws were enacted in the late 19th and early 20th centuries by white Southern Democrat-dominated state legislatures to disenfranchise and remove political and economic gains made by black people during the Reconstruction period.

Black codes and Jim Crow laws were laws passed at different periods in the southern United States to enforce racial segregation and curtail the power of black voters. After the Civil War ended in 1865, some states passed black codes that severely limited the rights of black people, many of whom had been enslaved.

Jim Crow laws originated from slave codes which prohibited slaves from learning how to read and write, gathering in groups for worship or bearing arms. Slave codes aimed at preserving slavery.

### JIM CROW LAWS AND AFRICAN AMERICAN DISCRIMINATION

Jim Crow law, in U.S. history, any of the laws that enforced racial segregation in the South between the end of Reconstruction in 1877 and the beginning of the civil rights movement in the 1950s. Jim Crow was the name of a minstrel routine (actually Jump Jim Crow ) performed beginning in 1828 by its author, Thomas Dartmouth ( “ Daddy ” ) Rice , and by many imitators, including actor Joseph Jefferson .

Segregation and Jim Crow Laws. The purpose of Jim Crow Laws was to separate white and black people. Restaurants, hospitals, schools, prisons, and the like were required to have separate facilities for whites and blacks. One famous example of this is the bus segregation laws. Rosa Parks who was required, as an African-American, to sit at the back of the bus. She did not, of course, and that helped lead to the Civil Rights Movement in the 1960s. Jim Crow laws did not only apply to southern states.

In response to Jim Crow Era laws and lynchings, African Americans in the South began participating in the Great Migration. African Americans moved to cities and industrial towns in the North and West hoping to escape the de jure segregation of the South. However, they were unable to elude de facto segregation, which barred African Americans in the North from joining specific unions or being hired in particular industries, purchasing homes in some communities, and attending choice schools.
