Article 254 TFEU provides that the number of judges shall be determined by the Statute of the Court of Justice of the European Union. Article 48 of Protocol No 3 on this Statute, as last amended by Regulation (EU, Euratom) 2016/1192 of 6 July 2016, provides that the General Court is to consist of 47 judges from 1 September 2016, and of two judges per Member State from 1 September 2019.
